



Alternative Consignment Method Agreement

1. **GENERAL:** "Once in a Blue Moon Online Thrift Store" agrees to accept shipment of consignor's merchandise to be included in "Once in a Blue Moon Online Thrift Store" consignment listings. "Once in a Blue Moon Online Thrift Store" will photograph, and list the consignor's item (s) on their web site at www.gone-tomorrow.com. "Once in a Blue Moon Online Thrift Store" will also promote the Consignment category through on-site promo ads and in the listing dialogue submissions to search engines. In consideration, "Once in a Blue Moon Online Thrift Store" will receive forty percent (40%) of the selling price of consignor's item (s), plus shipping fees collected, of each item sold on "Once in a Blue Moon Online Thrift Store."

3. **PAYMENTS:** Immediately following the notification to "Once in a Blue Moon Online Thrift Store" of a sale (by PayPal) of consigned item (s), sixty percent (60%) of the sale price, excluding shipping fees, shall be immediately sent to the consignor through their personal PayPal account. If the consignor does not have a PayPal account, payment through a bank check will be mailed to the address on record at the beginning of the following month for which the sale occurred.

3. **LIABILITY:** "Once in a Blue Moon Online Thrift Store" assumes no liability for the loss or destruction of consignor's merchandise in their possession through an 'act of God'. "Once in a Blue Moon Online Thrift Store" assumes no liability for the loss or destruction of consignor's merchandise during the shipping process to or from "Once in a Blue Moon Online Thrift Store."

4. **IMPERFECT** items shipped to "Once in a Blue Moon Online Thrift Store" to list on our site that are in need of repair or cleaning may be donated to charity unless consignor is willing to pay for return shipping. DONATION RECEIPTS AVAILABLE ON REQUEST ONLY.

5. **AGREEMENT TERMINATION:** This agreement may be terminated at any time and by either party. Once the consigned item is sold and shipped to the buyer, the agreement is terminated. All unsold items may be removed from the site within three (3) months from the date of consignment unless the consignment agreement is

renewed for another 90 days. All unsold (or if agreement is terminated) items in the possession of **"Once in a Blue Moon Online Thrift Store"** will be returned to the consignor on their written request and at the consignor's expense (Payment to **"Once in a Blue Moon Online Thrift Store"** for shipping charges must be received prior to returning the consignment item (s), unless the agreement is terminated by **"Once in a Blue Moon Online Thrift Store"** who will then pay for shipping in returning the merchandise to the consignor.

6. **BOOKKEEPING:** **"Once in a Blue Moon Online Thrift Store"** will maintain accurate records for receipt of, sale of, and/or return of consignor's merchandise. These records will be furnished to consignor when the merchandise is first received, after a sale, and at the termination of the agreement. Special requests for viewing the records may also be made to **"Once in a Blue Moon Online Thrift Store"** at any time by the consignor.

7. **CONSIGNMENT SALES:** **"Once in a Blue Moon Online Thrift Store"** agrees to treat each consignment sale customer with the same professionalism given to their regular customers. **"Once in a Blue Moon Online Thrift Store"** further agrees to package, and ship consignor's merchandise in the same manner in which they would ship their own merchandise.
